TERMS AND CONDITIONS OF TRADE

1. The Customer hereby warrants that the information comprised in this credit application is true and accurate.
2. The Customer warrants that the person/s who have signed this agreement are duly authorised by the Customer to apply for credit on behalf of the Customer.
3. The Customer agrees to comply with and abide by the terms and conditions of this agreement.
4. The Applicant agrees that it is not entitled to any credit facilities until it receives notice from the IL Gelato stating that the credit facilities have been given and specifying the terms. Until the Customer receives such notice from the IL Gelato any fees for goods or services that are supplied by the IL Gelato to the Customer shall be payable COD.
6. Terms of Credit are:
 - a. Terms of Trading are strictly **30 days** from the date of the invoice.
 - b. In the event the account is referred to a third party for collection of outstanding monies, all costs relating to such action shall be recoverable from the debtor in addition to all legal, court and solicitor costs.
 - c. If the invoice is not paid in full the Customer will be at fault, IL Gelato may charge the Customer interest on the amount outstanding calculated from the due date of payment, until payment is made in full. Interest shall be charged based on The Bank of Western Australia (BankWest) benchmark rate plus 3%.
 - d. IL Gelato reserves the right to stop supply in the event of these terms being exceeded.
